Participant agrees, in consideration of the stated benefits, to abide by the rules and payment structure set forth below:

Participant agrees that all funds paid to Mentor by credit card are good-faith funds and are non-cancelable. Participant agrees to never issue a "chargeback" to Mentor's merchant account at any time for any fees paid to Mentor by Participant. Participant agrees to contact Mentor directly with any billing issues.

Authorization Of Payment:

By completing the Application and signing below you authorize the Company to charge your credit card or cash your check as payment for your enrollment in the Program, if the Company approves your Application and accepts you into the Program. This is not an installment contract.

Facsimile or electronic signatures shall be deemed equivalent to original signatures for purposes of this Agreement.

Waiver:

The waiver or failure of Company to exercise in any respect any right provided for herein shall not be deemed a waiver of any further right hereunder.

Severability:

If any provision of this Agreement is invalid, illegal, or unenforceable under any applicable statute or rule of law, it is to that extent to be deemed modified in order to comply with applicable law, and the remaining provisions shall not be affected in any way.
